

**PRIVACY POLICY –
« SHOP AND WIN A DREAM HOLIDAY »**

Preamble

The game "SHOP AND WIN A DREAM HOLIDAY" is offered by LAGARDERE DUTY FREE, SAS with a capital of 5,260,470 euros, whose registered office is located at Tour Prisma, 4/6 avenue d'Alsace 92400 Courbevoie, registered in the Nanterre Trade and Companies Register under number 380 253 518 (" LDF ").

Aware of the importance of ensuring data confidentiality, LDF undertakes to protect personal data in accordance with the regulations in force on the protection of personal data, applicable in Europe and France. The purpose of this policy on personal data is to inform you about the commitments and practical measures taken by LDF to ensure that your personal data is respected during your interactions with the SHOP AND WIN A DREAM HOLIDAY game teams.

1. Purposes of collection

The processing operations carried out by LDF serve the following purpose : participation in the game called " SHOP AND WIN A DREAM HOLIDAY ", the rules of which are annexed hereto.

The game is offered at certain of the points of sale in the countries participating in the operation and invites the buyer of certain products to register online to participate in the game at the following address:

The data is recorded on the SHOP AND WIN A DREAM HOLIDAY game's website.

For this purpose, personal data are used for:

- Allow participation in the game SHOP AND WIN A DREAM HOLIDAY
- Receive newsletters by Aelia Duty Free
- Receive the Last Minute commercial offer to benefit from the discount

2. Collected Data

The data are collected via exchanges with the participating customer by authorised parties :

- The sales teams of participating Paris boutiques in France and abroad

Here is the list of the collected data:

- Basic identity (title, surname, first name, e-mail)
- Name of the airport where the customer participates in the game

LDF and its partners ensure that only data that are strictly necessary for the purpose of the processing operation are collected and processed.

3. Recipients of the data collected

Your personal data will only be used by identified and authorised persons:

- The agency organising the game
- The organising shops' sales force
- Lagardère Duty Free (LDF)

4. Commercial prospecting

You can choose to receive newsletters from LDF. You may then withdraw your consent at any time by contacting customer service. LDF undertakes not to disclose your data to third parties without your permission.

You can benefit from €30 discount on a booking with Lastminute.com by ticking the corresponding box. Lastminute.com undertakes not to recover and use the personal data to carry out commercial prospecting.

6. Data retention

The client data used and mentioned in section "2. Data collected" are kept for :

- The time necessitated by the purpose of their processing (active member)
- 3 years in other cases (inactive member)

At the end of these periods, these data will be irreversibly deleted.

7. Security

LDF ensures the security and confidentiality of your personal data by implementing enhanced data protection through the use of physical and logical security measures.

8. Your rights

In application of the regulations, you have a right of access, rectification, deletion, opposition and a right to the portability of all data concerning you. You also have the right to limit the processing using your personal data. Everyone also has the right not to be the subject of individual decision-making based exclusively on automated processing such as profiling. If you have consented to the processing of personal data, you may withdraw your consent at any time.
